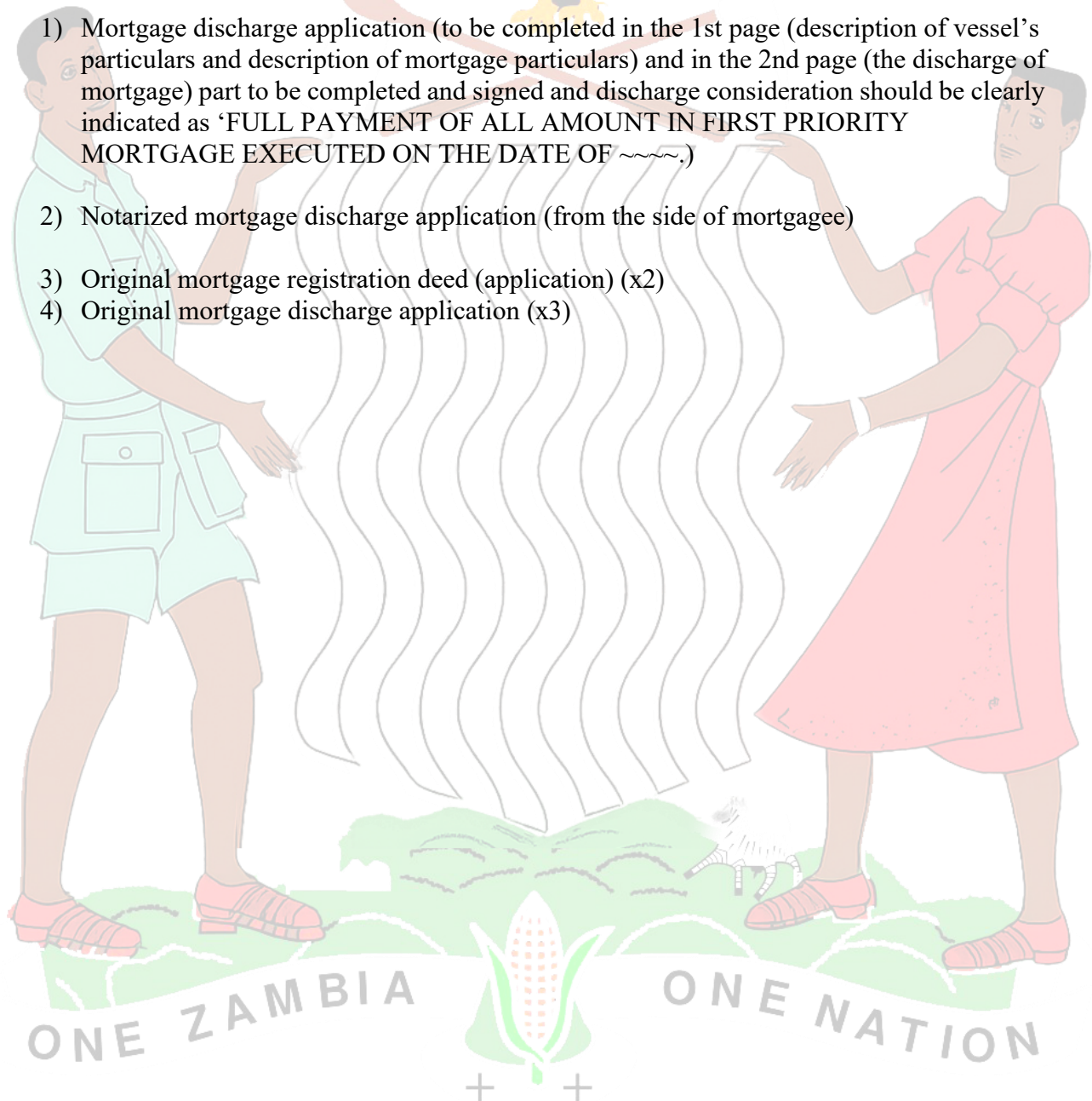




ZAMBIA SHIP REGISTRY

Documents needed for discharge of mortgage under Zambia flag:

- 1) Mortgage discharge application (to be completed in the 1st page (description of vessel's particulars and description of mortgage particulars) and in the 2nd page (the discharge of mortgage) part to be completed and signed and discharge consideration should be clearly indicated as 'FULL PAYMENT OF ALL AMOUNT IN FIRST PRIORITY MORTGAGE EXECUTED ON THE DATE OF ~~~~'.)
- 2) Notarized mortgage discharge application (from the side of mortgagee)
- 3) Original mortgage registration deed (application) (x2)
- 4) Original mortgage discharge application (x3)



Documents needed for **provisional TRANSFER of MORTGAGE registration** of a vessel under Zambia flag:

1. Consent letter from the Bank for transfer of Mortgage
2. Copy of Mortgage Registration Deed, signed by owners and bank only firstly.
3. Copy of transfer Mortgage Contract including loan agreement between mortgagor and mortgagee, signed by owners and bank only firstly.
4. Copy of Undertaking Letter from Owners that all requested **Original Notarized documents** will be submitted to us as below, within a period not exceeding 45 days
5. Closure of Mortgage or Deletion certificate from the current flag
6. Notarized declaration of ownership (not to call North Korea; Northern Cyprus; Crimea)

For **Permanent Mortgage Registration**, we need:

1. **ORIGINAL Notarized** transfer of Mortgage Registration Deed (transfer of mortgage registration application form) **(3) sets must be submitted to our office**
(In mortgage registration deed, mortgager's full name/signature/ position/ seal should be exactly indicated)
2. **ORIGINAL Notarized transfer of Mortgage Contract** (including notarized loan agreement)* between mortgagor and mortgagee: (3) sets must be submitted to our office
It should be notarized from both sides of mortgagor and mortgagee. And in signature part & notarization part, PIC's name & position & company name (both mortgager & mortgagee) in full should be exactly indicated
3. Original Undertaking Letter from Owners that all requested **Original Notarized documents** will be submitted to us as below, within a period not exceeding 45 days
4. Original Closure of Mortgage or Deletion certificate from the current flag
5. Original of Undertaking Letter from Owners that all requested **Original Notarized documents** must be submitted to us as below, within a period not exceeding 45 days
6. Original Notarized declaration of ownership (not to call North Korea; Northern Cyprus; Crimea)
